4. Assignment of Loading and Unloading Time Points for Trucks a.

- a. The loading time point should generally be determined one day before scheduled loading time, in written form preferably, with the responsible H&R dispatch departments (see persons in charge, point 2 and 3).

5. Demurrage Regulations

- a. In case of restraints of the loading process caused by the forwarding agent (such as inadequate cargo securing materials or lack of required documents) H&R charges the forwarding agent EUR 25.
